

## North Cork Community Radio Co-op. Society Ltd.

#### BACKGROUND

The ongoing debate concerning Community Radio, would seem to be reaching a satisfactory conclusion i.e. the setting up of an Independent Authority, which in compliance with new legislation, will be enpowered to issue broadcast licences to local community stations. A local radio service has been provided from Mallow for the past five years by a voluntary body. This service covering a reasonable radius of the surrounding area, gives a clear indication of the existance of the will and the expertise which are available to undertake such a service.

It is necessary, however to consider major changes which will broaden the base of the entire operation, widen its scope, and strengthen the case for granting a broadcasting licence for the area as defined on the accompanying map.

#### PROPOSAL

A new structure has been formed to put the case for licence, once legislation is available. This is a Community Co-Operative called N.C.C.R. (North Cork Community Radio) Co-Operative Society Ltd., and has been registered with the Irish Co-Operative Organisation Society (I.C.O.S.) which is the National Statutory Body.

The Co-Op is currently run by an interim management Committee (which issues this brochure) It is now necessary to seek investment in this structure. Investment categories are as follows:-

- (1) Statutory Bodies: Urban and Co. Councils etc.
- (2) Voluntary Clubs and organisations.
- (3) Business and Commercial interests.
- (4) Private individuals.
- (5) Persons who may be prepared to work for the new Station.

#### ADVANTAGES

The main advantages of a Co-operative approach to this question are:

- It ensures that control of the station is vested in the community.
- (2) It ensures a high level of community involvement/ content in programmes presented.

For individual investors the advantages would include:

- (1) Publicity of events run by voluntary bodies etc.
- (2) Special advertising rates and allocation of prime time slots for category 3 investors.

#### **FINANCES**

Financial investment is necessary at present to:

- (1) Secure studio facilities and equipment.
- (2) Provide office facilities/equipment and reception facility.
- (3) For administration purposes.


In the future, it would be necessary for the Co-Op. to employ permanent full time staff for the effective and efficient running of its interests.

#### INVESTMENT METHODS

Investment categories as listed previously may purchase same up to the maximum limit of 3,000 shares. Shares can be purchased in £5 Blocks.
